CANCELLATION POLICY FOR INDIVIDUAL RESERVATIONS

The Client acknowledges that the Hotel is relying on their guest's use of the Guest Room Commitment and that cancellation of individual reservations, for reasons other than force majeure, would cause the Hotel harm. The Client therefore acknowledges the below cancellation policy that will be applied to individual reservations in the group room block. Individual guests who cancel reservations will compensate the Hotel, as liquidated damages and not as a penalty, the amount listed in the chart below:

| 13 days or less prior to the arrival date | 100% of the total dollar value of the reservation |
| No Shows and Early Departures are considered Cancellations and will be charged | 100% of the total dollar value of the reservation |

CANCELLATION OR TERMINATION OF ROOMS AGREEMENT BY GROUP

The Client acknowledges that the Hotel is relying on Client's use of the Guest Room Commitment and that cancellation of the Guest Room Commitment, or Adjusted Guest Room Commitment, for reasons other than fire, catastrophe, or act of God, would cause the Hotel harm. The Client therefore agrees to compensate the Hotel, as liquidated damages and not as a penalty, the amount listed in the chart below:

| PERIOD | DAMAGES |

| 90 days or more prior to the arrival date | No damages assessed; full deposit refunded |
| 90-45 days or more prior to the arrival date | 25% of the total dollar value of the room block |
| 45-30 days or more prior to the arrival date | 50% of the total dollar value of the room block |
| Between 30-14 days prior to the arrival date | 75% of the total dollar value of the room block |
| 14 days or less prior to the arrival date | 100% of the total dollar value of the room block |
| No Shows and Early Departures are considered Cancellations and will be charged | 100% of the total dollar value of the guestroom |
